## **Position Summary:**

The **Animal Advocacy Lawyer** works to uphold and strengthen animal protection legislation on municipal, provincial and federal levels. Working closely with the CEO and the animal advocacy department, this position will be a driving force in assisting the organization to improve the welfare of farmed, wild and domestic animals throughout the province of Manitoba.

## **Duties and Responsibilities:**

- Providing legal analysis of animal welfare legislation on a municipal, provincial and federal level.
- Working with the animal advocacy department to research, develop and execute initiatives that improve animal protection legislation while mobilizing supporters to take action.
- Scheduling and partaking in meetings with government officials and stakeholders on a variety of animal welfare issues.
- Providing legal advice to the CEO and animal welfare department on animal welfare violations, proposed legislative changes, and more.
- Working with appropriate stakeholders to craft new policies, regulations and legal protection for animals.
- Tracking and flagging relevant opportunities to address proposals, amendments and/or violations of animal protection legislation.
- Reviewing incident reports provided by various watchdog groups and file legal complaints as needed.
- Sharing written and verbal commentary on welfare issues with media as needed.
- Coordinating with external legal counsel as needed on public interest.
